### **BY INVITATION ONLY: MBPJ's HEARING ON PROPOSED HEALTH METROPOLIS TAKES PLACE TOMORROW,; THE STAR, 6 SEPTEMBER 2013.**

The consultation in relation for obtaining public feedback before deciding whether an amendment should be made to RTPJ 1 is open to all members of the public.

Section 12 A, Town and Country Planning Act, requires the local authority before it consider whether to proceed with a draft amendment of a local plan to give such publicity of its intention, objective and purpose for proposing a draft amendment of the local plan and the law requires the local authority to give opportunity to everybody who deserves to make preparation and that they made aware of that opportunity. MBPJ is doing this in 3 stages:-

#### Stage 1:

To invite all immediate neighbours for their views.

#### Stage 2:

Which is to put in newspaper advertisement in two newspaper for all members of the public, and upload in MBPJ website.

#### Stage 3:

To e-mail to all registered Resident Association (RA) and Rukun Tetangga (RT) with MBPJ.

As such there will be more than one session. We wish to point out the visual in the article is incorrect as well as the statement, only people invited can attend. Anybody can attend but for logistic purposes we split it to several sessions. The statement made that it is mandatory to put in the newspaper as the only way for a discussion under Section 12 A, is legally incorrect.

The person who makes the statement is confused between publicity relation Section 13, that is when the draft is already prepared and table for objection and Section 12 A, which is a preliminary consultation before a preparation of draft.

In any case, we are going to do it in 3 stages as outline above. We hope this clarify the issues. We advise all residents to come in any of the session.
